- An order dispensing with the forms, service and time periods prescribed in terms of the Uniform Rules of this Court and directing that the matter be heard as one of extreme urgency in terms of Rule 6(12) of the Uniform Rules of Court;
- 2. An order is issued dispensing with the citation requirements in Rule 6(2) in respect of the 6th Respondents.
- 3. That a *rule nisi* hereby be issued herewith in terms of which the Respondents are called upon to show cause on **Tuesday the 27**th of

February 2024 why an order in the following terms should not be made a final order of the above Honorable Court:

- 3.1 That the Respondents be interdicted from committing any act which is prejudicial to the good name, administration, discipline or efficiency of the Applicant or acting in any way which is detrimental to the name and normal functioning of the Applicant.
- 3.2 That the Respondents be interdicted from interfering with the administration of the Applicant;
- 3.3 That the Respondents be interdicted from instructing or affecting or causing any employee, staff member or official of the Applicant to vacate their offices and or leave any of the campuses of the Applicant;
- 3.4 That the Respondents be interdicted from threatening, intimidating, assaulting and or harassing any of the employees, staff members and or officials of the Applicant.
- 3.5 That the Respondents be interdicted from committing arson at or near all of the Respondents campuses to wit, Cicirha Campus, Zimbane Campus, Libode Campus, Mngazi Campus

Port St Johns, Maphuzi Campus, Ntabozuko Xhora Campus and Engcobo Campus
